More Offshore Drilling?

In early-January 2018, US Secretary of the Interior Ryan Zinke announced a plan to expand offshore drilling on the Atlantic, Pacific, and Gulf coasts of the United States. The plan was met with opposition from many state governors, including Florida governor Rick Scott who expressed concern for Florida's natural resources. Following a meeting between Secretary Zinke and Governor Scott, Florida was granted an exemption from offshore drilling. For more on the issue, see the January 8, 2018 article

Northwest Florida to Eastern Time?

A bill called the "Sunshine Protection Act" is moving through the Florida legislature that would shift Northwest Florida from the Central to the Eastern Time Zone. Sponsored by Sarasota Representative Greg Steube, the proposal includes a provision to retain daylight savings time year-round. Pensacola Downtown Fish Hatchery Project Stalled

The planned construction of the \$19 million Gulf Coast Marine Fisheries Hatchery & Enhancement Center" on Main Street between Joe Patti's and Blue Wahoos Stadium is on hold. Responding to "pending litigation" and likely the removal of some local support, the Florida Department of Environmental Protection has canceled "the solicitation for construction bids on this project until further notice."
