Perdido Key and COVID 19

Whether on Perdido Key or elsewhere, we are all monitoring the COVID 19 epidemic across the United States and the world. What seemed a distant problem now has the US medical community, federal, state, and local authorities, along with companies, institutions, and private citizens working to control its spread and effects – with a first Perdido Key case reported on March 31. Staying home can be good for family time and for catching up on projects, but we would all prefer isolation as a choice and not a need.

To keep group size to a minimum, at its March 20, 2020 Special Meeting the Escambia County Board of County Commissioners (BOCC) decided to close Escambia County public beaches, including those on Perdido Key; Gulf Islands National Seashore and Perdido Key State Park closed as well. The beach closure will last at least until the next scheduled BOCC meeting (April 2, 2020). The Perdido Key Area Chamber of Commerce has worked hard to clarify the beach closure decision and other preventive actions. While public beaches have been closed, government mandate has not closed private beaches. On March 27, 2020, Governor DeSantis issued Executive Order 20-87 suspending Vacation Rentals for two weeks, specifically: "...vacation rental properties are prohibited from making new reservations or bookings and shall not accept new guests for check-in for the next two weeks. The order applies to any house, condo, cooperative or dwelling unit that is also a transient public lodging establishment. The order does not apply to resorts, inns, hotels, motels or

Janitorial and other essential services continue but contracts and other commitments must be worked out between owners, affected firms, and individuals. With beaches and related activities closed, those dependent on our area's service industry for their livelihood should not be forgotten. One hopes the social distancing measures taken, along with more testing, warmer weather, and some luck will flatten the rate of COVID 19 increase – allowing for serious consideration of when rentals, restaurants, shops, and public activities can begin returning to normal.

Staying Healthy

COVID 19 is extremely infectious so considerable direction has been given on how to impede its spread. The following guidance is from the Escambia County web location on COVID 19: "stay home when you are sick; cover your cough or sneeze with a tissue, then discard in trash; avoid close contact with people who are sick; avoid touching your eyes, nose, and mouth with unwashed hands; wash your hands often with soap and water for at least 20 seconds; use an alcohol-based hand sanitizer that contains at least 60% alcohol if soap and water is not available; and, clean and disinfect frequently touched objects and surfaces." The federal social distancing mandate was just extended to April 30, 2020 while travel and quarantine instructions have been issued by various authorities.
