## **Perdido Incorporation Initiative Moves Forward**

On October 26, 2023 Escambia area's Florida legislative delegation voted unanimously to approve draft legislation to create a new municipality in the area proposed by the "We Are Perdido" initiative. Large crowds spoke for and against the proposal at the meeting of the delegation held at Pensacola State University. As the We Are Perdido website states, following the approval: "The next step in that process is a continued review of the feasibility report in local subcommittee, an update of all budget projections using FY 2024 data, followed by more committees prior to arriving on the [Florida] House floor for a vote in the January/February 2024 legislative session. If it passes in both the House, Senate, and the Governor's desk, citizens of Perdido would for the very first time in history have the opportunity to vote on becoming a town." The action follows an active couple of weeks where the initiative was discussed at the October 19, 2023 Escambia Board of County Commissioners meeting and permission given to "We Are Perdido" leader Steve Brendtro for the organization to liaison with County departments on how interlocal agreements can be crafted; the County has such arrangements with the City of Pensacola and Town of Century. There was also a recent meeting of a group opposed to incorporation called "Stop Perdido City." ### **Beach Access RESTORE Funds Comment Period**

Escambia County's proposed "Restore Act Multi-Year Implementation Plan Amendment 3" includes a request for "Perdido Key Public Beach Access - Property Acquisition and Construction." The \$3.6 million request states in part: "Potential amenities include public parking and a dune walkover with observation platform. Undeveloped areas may be enhanced through habitat restoration to maximize benefits to the endangered Perdido Key beach mouse.

A near-shore artificial reef may be designed and permitted for increased recreational opportunities and to improve fishery habitat for snorkeling, diving or fishing. Public access infrastructure provides connectivity and access to the artificial reef, allowing for the resources to be enjoyed by the public." Along with the 75 foot public easement issue affecting many beachfront property owners, the proposed RESTORE amendment could have a significant impact on Perdido Key's future. The public comment period for the proposal extends to December 1, 2023. # **River Road Closure Update**

River Road closure for through traffic will begin on November 1, 2023 following a postponement from the previous October 16 date to resolve last minute concerns. Repair work will replace the culvert running underneath the roadbed and construct a conventional pedestrian/bicycle multi-use path in place of the current wooden bridge.

The Perdido Key Multi-Use Path is growing at lightning speed as workers construct multiple portions at once, including south of the roundabout at the Perdido Key Drive/Johnson Beach Road intersection and in Perdido Key State Park. The path will be terrific for Perdido Key!

### **Controlled Burns**

Florida State Park personnel are conducting controlled burns at various locations in Big Lagoon State Park and Tarkiln Bayou Preserve State Park, rain and wind conditions permitting. Controlled burns remove debris and unwanted plants and help rejuvenate soil in forested areas, among other benefits.
