County Approves Resolution Opposing Oil Drilling in the Gulf

At its December 11, 2025 meeting, Escambia County Commissioners approved a resolution opposing recently published plans by the federal government to allow oil and gas drilling in the eastern Gulf offshore Florida.

1000 Friends of Florida and others have been pushing for revision to recently passed Florida law SB 180 that, among other actions, reduces local control over development. "State Sen. Nick DiCeglie, R-St. Petersburg, recently filed SB 840, a bill that aims to clarify and narrow the scope of SB 180 while striking parts of the law entirely." While the bill could restore more local control, some say it does not go far enough. Large River Road Development Approved

On December 10, 2025, the Escambia County Development Review Committee (DRC) approved construction of "River Road Villas," a multifamily development with 29 multistory buildings on 6.52 acres of open land between River Road, Semmes Road, Garden Glen Drive, and Sweet Retreat Lane (i.e., the Serenity subdivision). Access to the housing will be from River Road.

Change to Free Days at National Parks

According to the National Park Service, the Martin Luther King Jr. Day and Juneteenth holidays have been removed from the 2026 calendar of entrance free days for National Parks, including the Perdido Key Area of Gulf Islands National Seashore (Johnson Beach). June 14 (Flag Day as well as President Donald Trump's birthday) will now be a free admissions day along with August 25 (110th anniversary of the National Park Service), September 17 (Constitution Day) and October 27 (President Teddy Roosevelt's birthday). Volunteer County Tree Planting

Escambia County is providing residents with three opportunities to assist in planting trees in the county. On January 16, 2026, volunteers can meet at the Escambia County Central Office Complex at 3363 W. Park Place (just off Fairfield Drive) "to help transport trees and mulch"; on January 17 they can meet at the "Escambia Extension Office, 3740 Stefani Road, at 8:30 a.m. to watch a short tree planting demonstration before heading out to assigned locations with a team to plant trees"; and, on January 24 they can meet at "Galvez Landing, 5820 Cruzat Way, at 8:30 a.m. to watch a short tree planting demonstration before leaving to assigned locations with a team to plant trees." "Trees will be planted in the right of way or front yards of residents who have applied for trees through the Canopy Restoration Project." Bear Hunt Results

According to the Florida Fish and Wildlife Conservation Commission (FWC), hunters killed 52 black bears during Florida's 2025 black bear hunt. That is considerably fewer than the 172 harvest permits FWC had issued. Extended Stay Hotel May be Sold

The vacant and decaying Suburban Extended Stay Hotel on Barrancas Ave near Navy Blvd in Warrington may be sold to Blackhawk Asset Management and reopened as a hotel after renovation. The building has been in disrepair since damaged by Hurricane Sally and a site of reported drug use, domestic violence and unauthorized occupation. Escambia County could forgive the accumulated fines of almost \$400,000 on the property if the purchase moves forward. "We are just working with the new potential owner to bring redevelopment back to that neighborhood and eliminate a source of blight," said Escambia County Natural Resources Deputy Director Tim Day. "It either needs substantial renovation, or it needs to come down." Pensacola Beach Gateway Improvements

Escambia County will begin the “Pensacola Beach Gateway Improvements Project” in January 2026 to replace the Bob Sikes Toll Plaza on Pensacola Beach and replace it with “a new toll gantry with applicable toll-by-plate equipment, CCTV cameras, and new fiber optic communications.” The new facility “will offer enhanced safety features, such as better access for emergency response vehicles, while also helping to reduce congestion at the entrance to Pensacola Beach.” For more on this issue, go to the December 19, 2025 *County News Center* article [Pensacola Beach Gateway Improvements Project to Begin January 2026](#).

Gulf Shores Pedestrian Bridge

With pedestrian access being removed to allow more traffic lanes on Rt. 59’s W.C. Holmes Bridge crossing the Intracoastal Waterway, the City of Gulf Shores is constructing a pedestrian bridge nearby. Mountainfilm Tour

“Mountainfilm is a non-profit organization and festival that celebrates stories of indomitable spirit and aims to inspire audiences through film, art and ideas.” Following its annual film festival, the organization goes on tour “sharing the year's most inspiring short films with communities worldwide.” The Tour will appear on January 17, 2026 at the Pensacola Little Theatre where tickets can be purchased. The proceeds will help support the Pensacola and Perdido Bays Estuary Program (PPBEP) and Healthy Gulf.

Living Shoreline Assistance

The Living Shoreline Assistance program supports waterfront property owners and community groups in addressing erosion and restoring habitat across local area estuaries. Open Houses on the program will be held in Pensacola on January 21 and February 18, 2026 from 2-8 PM at the Sanders Beach-Corinne Jones Resource Center, 913 S I St, Pensacola, FL 32502.

PPEBP Education and Outreach Intern Position

Plastic Threats to Ocean Animals

A recent Ocean Conservancy web entry on plastic pollution provided disturbing information on how plastics and other man-made substances are killing sea life. Only a few pieces of balloon rubber smaller than a pea can kill a seabird; less than half a baseball of plastic can kill a loggerhead sea turtle; and, when marine mammals consume 12 pieces of soft plastic like grocery bags, models predict a 50% chance of the animal's death. Green Turtles Not “Endangered”

Green sea turtle status has been changed by the International Union for Conservation of Nature (IUCN) from “endangered” to “least concern.” According to the Turtle Foundation, “After decades of intensive conservation efforts, the global population of these sea turtles has increased by around 28 percent since the 1970s – an impressive testament to the effectiveness of consistent conservation action.” The article also warned that “Many regional populations remain at risk, and threats such as the illegal trade in eggs, hunting, bycatch in fishing nets, the loss of critical nesting beaches, and the impacts of climate change continue to endanger their survival.” For more on this issue, go to the *Turtle Foundation* web entry “IUCN: Green Sea Turtle No Longer Endangered – A Success for International Species Conservation” at [Green Sea Turtle No Longer Endangered| Turtle Foundation](#).

Water Quality Funding Hopes

The Northwest Florida Water Management District hopes to obtain Florida State funding “to improve the region’s water quality, protect its water supply and allow for habitat restoration in fragile ecosystems.” The plan will focus on “sub-basins” within the region’s seven watersheds with “11 Mile Creek within the Perdido Bay watershed and Carpenter Creek and Bayou Texar, which feed into Pensacola Bay” tentatively selected as Escambia County sub-basins for consideration.
